### GENERAL INFORMATION:

- Those who want to register to single courses will need to proceed paying the fees according to the amounts established by the University.
- To the registered student will be given an identification document to use during the attendance of the classes and for taking the exam.
- The exam taken at the end of the course, by previous determination of the Department Council of interest, can be recognised to those who have a high school diploma or a Bachelor Degree in order to enroll in a Degree course.
- Those registered to the single courses will be considered as **students**, so they'll have to respect the rights and obligations established by the Students Regulation.
